Tort Reform Re-Enacted During Special Session

After just 5 days, the Special Session of the Oklahoma Legislature adjourned Monday, September 8th, after passing 23 separate bills. The bills represented the sections of the 2009 Comprehensive Tort Reform bill which the Oklahoma Supreme Court struck down in June based on the 2009 bill violating the Constitutional "single subject" rule.

Two issues of special interest to the Consulting Engineering community during the Special Session were "Joint & Several Liability" reform and the "Certificate of Merit." During the Special Session it was determined that because amendments to that statute had been adopted since the 2009 law enacted, the Joint & Several repeal of 2009 was unaffected by the Supreme Court's decision, so no action was necessary.

The "Certificate of Merit" was another story, and was the hotbutton issue of the Special Session. In it's June ruling, the Supreme Count ruled it unconstitutional stating that it created a barrier to the courts and was a "special law" pertaining only to "professionals."

The Legislature did reinstate the "Certificate of Merit" provisions, but made two changes in an attempt to placate the Court by refining the waiver process for indigent people to resolve the "access" problem, and, changed the language from "professional" negligence to "all" negligence cases involving an expert witness. The bill passed the Senate 33-11, but after a House vote of 51-36, the House rejected the "emergency clause" meaning the bill won't go into effect until mid-December.

Many at the Capitol expect a court challenge to the revised Certificate of Merit law, so we may not have heard the last of this. But, for now, in mid-December it becomes law again. September, 2013 Page 3

When he returned to Oklahoma, he obtained a degree in engineering. He began working in Oklahoma City, where he met his bride, Barbara Reuter, whom he married on April 12, 1958. They resided in Oklahoma City, where he partnered with Tom Determan to create Determan-Scheirman Consulting Engineers, where he worked full time up until June, 2013

David served as ACEC OKLAHOMA President in 1990-91, and was a highly respected member of and leader in the Oklahoma engineering community.

He joins his wife, Barbara, in eternal life; as well as his parents; brother, Richard Scheirman; and sister, Marian Scheirman Epperson. He is survived by his children: Sandra Plain and husband Kary, of Plano, TX; son, John Scheirman and wife Lisa, of Norman, OK; and Susan Schmidt and husband Dwayne, of Oklahoma City; as well as four grandchildren, Ryan Plain, Sarah Plain, Jacob Schmidt, and Luke Schmidt.

Dave is described by friends as witty, upbeat, unselfish, as having a happy energy that people were drawn to, "never met a stranger" and lived a great example of a full life. He adored his grandchildren and spent most of his free time with them and his children. He enjoyed music, theater performances, traveling and relished riding the right seat of the cockpit.

Paul William Matthews, 81, passed away on September 8, 2013, in Nichols Hills. He was born in Joplin, MO, on January 3, 1932, the son of Paul Newman Matthews and Bernice Sutton Matthews. He spent his early life in Neosho, MO, before moving to Miami, OK, and then to Guymon where he graduated from high school.

Paul entered Oklahoma A&M College and majored in political science and graduated from in 1954 with a bachelor's degree in political science and was commissioned a second lieutenant. Following military service at Fort Bragg, NC, Paul entered chamber of commerce management in Mendota, IL, and Kenosha, WI. He received his organization management degree from Michigan State University and then entered association management with the National Highway Users Federation in 1962 as Regional Director of Oklahoma, Missouri, Kansas, Arkansas, Illinois and New Mexico and served until early retirement in 1993. President's Report

September, 2013 David Raymond, ACEC President

As you head into the Labor Day weekend, please know that your Council has had an active August pressing our agenda with key governmental agencies and advancing the recommendations of our various committees, coalitions, councils and forums that form the backbone of ACEC's policy-making and grass-roots activities. September will be a crucial legislative month, with the federal debt ceiling and needed action on overall government funding high on Congress' to-do list. One of ACEC's major priorities is the Water Resources and Development Act which is expected to be considered by House Committee in September with floor action to follow immediately afterwards. At Committee Chairman Bill Shuster's (R-PA) request, ACEC is working with legislators to build support for WRDA; it would represent the first major infrastructure initiative to come out of the House, as well as a key test vote ahead of larger infrastructure initiatives. Our Fall Conference in Scottsdale, Arizona has record numbers of advance registrants spurred by a strong business program and notable speakers; early registration discounts continue through September. Have a great holiday weekend.

General

- * Co-sponsored the State Transportation Leaders' Summit at the National Conference of State Legislatures, August 12, featuring U.S. DOT Secretary Anthony Foxx, state lawmakers and agency leaders focused on transportation funding at the state level.
- * Addressed ACEC/North Carolina's summer conference on current political and business issues (participation included two North Carolina state legislators who are members of ACEC/NC), and briefed ACEC/WV on industry initiatives in Congress.
- * Summer Coalition meetings of CASE, COPS, LDC and DPC were highly productive, creating new practice documents and "tools" and generating support for various ACEC political initiatives.

Government Advocacy

- * Advocated a broad-based national energy policy, hydraulic fracturing, and a broad definition of clean energy with Rep. Diane DeGette (D-CO) and staff from the office of Senator Mark Udall (D-CO) during the ACEC Environment and Energy Committee meeting in Denver.
- * Australian Embassy staff briefed ACEC's International Committee on public and private partnerships (P3s) in Australia and opportunities for U.S. firms.

Government Advocacy (cont)

- * Key government agencies (Corps of Engineers, Small Business Administration, Air Force, and State Department's Office of Overseas Building Operations) briefed ACEC on funding, impact of sequestration, and future programs.
- * Updated representatives of twenty federal agencies involved in export promotion on the needs and challenges facing U.S. engineering firms overseas.
- * Supported an increase in right-of-ways, permits, and temporary easements to construct, operate, and maintain oil and natural gas pipelines on federal lands by endorsing the Energy Infrastructure Improvement Act to grant issuing authority to the Department of Interior (DOI), rather than Congress.
- * Supported the expanded availability of low cost capital for renewable energy projects by endorsing the Master Limited Partnerships Parity Act, introduced by Reps. Ted Poe (R-TX) and Sen. Christopher Coons (D-DE).
- * ACEC/Washington became the sixth state to meet its PAC fundraising goal for 2013, further contributing to this year's record-breaking pace for PAC fundraising.
- * ACEC/PAC hosted fundraising events for Reps. Rick Larsen (D-WA), Darrell Issa, (R-CA), Dave Joyce (R-OH), Rep. Steven Horsford (D-NV), and Senator Pat Toomey (R-PA).
